1. Article B.6 Contract Funding is deleted in its entirety and replaced as follows:

B.6 CONTRACT FUNDING (1852.232-81) (JUN 1990)

(a) For purposes of payment of cost, exclusive of fee, in accordance with the Limitation of Funds clause, the total amount allotted by the Government to this contract is \$ 28,639,292.11. This allotment is for Utilization Mission Support and covers the following estimated period of performance: date of contract award through October 20, 1997.

(b) An additional amount of \$ 1,639,659.98 is obligated under this contract for payment of fee.
