PRIMARY EQUIPMENT USERS SIGNATURES ARE SUPPOSED TO BE OBTAINED BY THE CUSTODIAN PRIOR TO MANAGER APPROVAL. HOWEVER, IN THE PCM, A NEMS TRANSACTION USER NUMBER CHANGE DOCUMENT IS GENERATED TO OBTAIN A PRIMARY EQUIPMENT USERS SIGNATURE AFTER A MANAGER APPROVES THE TRANSACTION. ACCORDING TO NHB 4200, PARAGRAPH 4.506c, THE NEMS EQUIPMENT MANAGER WILL ENSURE THAT ALL NASA FORM 1602'S ARE SUBMITTED WITH REQUIRED APPROVALS AND APPROPRIATE SUPPORTING DOCUMENTS PRIOR TO DATA ENTRY BY THE NEMS CONTROL REPRESENTATIVE.
